

Global United Pageant™ Titleholder Contract

1. Global United Pageant™ Titleholders agree to attend the finals the following year and provide their own transportation to the event. The Pageant will provide all meals, special gifts, and any other available means.
2. Global United Pageant™ International Titleholders may NOT hold concurrent titles in another pageant. The winners of The Global United Pageant™ International Live Program are requested to maintain the Global United Pageant™ title as their focus of attention during their term and defer further competition until the completion of their reign. Competition in another program will result in disqualification from possible Lifetime Queen eligibility and possible revocation of the International Title.
3. Global United Pageant™ Titleholders must complete 12 appearances by the next year's pageant finals. One must be done in every month and posted to social media, including facebook, TikTok, and instagram while tagging the director (@WendyGUZimmerman) and using the hashtags #GUPageant and #GlobalUnitedPageant to count toward your appearances. Returning to the pageant to crown the following year's successor counts as one appearance. Titleholders are encouraged to do more than the minimum.
 - a. Titleholder MUST BE in Crown/Banner, Banner Only, or in apparel that clearly states that the titleholder is representing The Global United Pageant™.
 - b. Titleholder Must have a clean and neat appearance while representing The Global United Pageants™. Makeup must be worn, hair must be neat and tidy, and deodorant/perfume must be worn.
 - c. If the Titleholder has not completed the required six (6) appearances by January 31, 2025, the Titleholder will be required to relinquish their crown to the runner-up of their division.
4. Titleholders agree to be active on the contestant Facebook page, posting at least twice (2 times) a year on The Global United Pageant page talking about their year. One post being completed by August 2024 and the following in the month of January 2025. The Global United Pageant (™) will provide the Facebook Page that The Titleholder will use.
5. Titleholder will agree to be active on the Global United Pageant Contestant and Titleholders group providing tips to the contestants in the up-coming year. One post being completed by January 2025 and one in the month of January 2025.
6. The Pageant, its Director, and other involved parties are held harmless for any and all claims for damage or loss to persons or property by reasons of pageant participation or events related thereto.

7. While The Global United Pageant™ will provide suggestions, The Titleholder is responsible for scheduling their own personal appearances at their own cost. The Titleholder is completely responsible for all fees and costs endured while an International Queen.
8. Titleholders acknowledge use of pageant likeness by The Pageant, its Director, and other involved parties for the purposes of advertising without compensation for the same.
9. Decisions made by the Global United Pageant™ Executive Director are final and irrevocable.
10. Titleholder agrees to hold the Global United Pageant™ in the highest of respect and will not make comments or correspond in such a manner as to be considered slanderous or libel to her fellow queens, delegates, judges, the Global United Pageant™ staff, Executive Director, or any party directly related or in connection to the Global United Pageant™. Any comment or correspondence found true will result in immediate relinquishment of the Global United Pageant™ title.
11. If for any reason the Global United Pageant™ Titleholder is disqualified and title is revoked, the Titleholder will return to the Global United Pageant™, in like-new condition, all prizes, crowns, sash, any monies, sponsored items, and all other appointments made due to that title.
